Dupa cum probabil stiti, in data de 29.12.2022 a intrat in vigoare procedura de utilizare si functionare a sistemului national privind monitorizarea transporturilor de bunuri cu risc fiscal ridicat **RO e-Transport**, legislatie ce poate fi accesata aici :

Pentru a va usura experienta cu noul sistem,va reamintim criteriile de incadrare care fac obiectul monitorizarii RO e-Transport:

Vehiculele care au o greutate maxima tehnic admisibila de minimum 2.5 tone, incarcate cu bunuri cu risc fiscal ridicat cu o greutate totala (cu tot cu ambalaj) mai mare de 500 kg sau o valoare totala maimare de 10.000 lei fara TVA.

**Bunurile cu risc fiscal ridicat transportate rutier
care fac obiectul monitorizarii prin sistemul RO e-Transport**

- Legume,plante,radacini su tubercuulili, alimentare, care se incadreaza la codurile NC de la 0701 la 0714 inclusiv
- Fruce comestibile ;coji de citrice si sau de pepeni,care se incadreaza la codurile NC de la 0801 la 0814 inclusiv
- Bauturi, lichide alcoolice si otet, care se incadreaza la codurile NC de la 2201 la 2208 inclusiv
- Sare,sulf,pamanturi si pietre,ipsos, var si ciment,care se incadreaza la codurile NC 2505 si 2517
- Imbracaminte si accesorii de imbracaminte,tricitate sau crosetate, care se incadreaza la codurile NC de la 6201 la 6212 inclusiv si la codurile NC de la 6214 la 6217 inclusiv
- Incaltaminte, ghete si articole similare ;parti ale acestor articole, care se incadreaza la codurile NC de la 6401 la 6405 inclusiv
- Fonta, fier si otel, care se incadreaza la codurile NC 7213 si 7214

Daca aveti o expediere ce contine bunuri cu risc fiscal ridicat cu o greutate (cu tot cu ambalaj) mai mare de 500 kg sal o valoare totala mai mare de 10.000 lei, fara TVA, trimiteti un email pe adresa office@irs.ro sau sales@irs.ro cu adresa completa de ridicare pentru a putea identifica numarul masinii cu care se va face preluarea.

Prin expediere se intelege un document de transport(AWB sal CRM).

Veti primi din partea noastra in cel mai scurt timp posibil, numarul de inmatriculare al masinii care va prelua comanda.

In a constantly changing economic and social context, it is important to remain vigilant and adapt to the latest legislative changes.

As you probably know, on 29.12.2022 the procedure for the use and operation of the national system for monitoring the transport of goods with high fiscal risk **RO e-Transport** came into force, legislation that can be accessed here:

To make your experience with the new system easier, we remind you of the eligibility criteria that are subject to RO e-Transport monitoring:

Vehicles that have a technically permissible maximum weight of at least 2.5 tons, loaded with high fiscal risk goods with a total weight (including packaging) of more than 500 kg or a total value of more than 10,000 lei without VAT.

Goods with high fiscal risk transported by road

which are subject to monitoring through the RO e-Transport system

- Vegetables, plants, roots and tubers, food, which fall under CN codes from 0701 to 0714 inclusive
- Edible fruits; peels of citrus fruits and/or melons, which fall under CN codes from 0801 to 0814 inclusive
- Beverages, alcoholic liquids and vinegar, which fall under CN codes from 2201 to 2208 inclusive
- Salt, sulphur, soils and stones, gypsum, lime and cement, which fall under NC codes 2505 and 2517
- Clothing and clothing accessories, knitted or crocheted, falling under CN codes from 6201 to 6212 inclusive and from CN codes from 6214 to 6217 inclusive
- Shoes, boots and similar articles; parts of these articles, falling under CN codes 6401 to 6405 inclusive
- Cast iron, iron and steel, which falls under NC codes 7213 and 7214

If you have a shipment containing high fiscal risk goods with a weight (including packaging) of more than 500 kg or a total value of more than 10,000 lei, excluding VAT, send an email to **office@irs.ro** or **sales@irs.ro** with the full pick-up address to be able to identify the number of the car that will be picked up.

Shipping means a transport document (AWB sal CRM).

You will receive from us in the shortest possible time, the registration number of the car that will take over the order.
